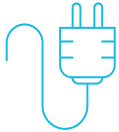

## 3 Find configuration page

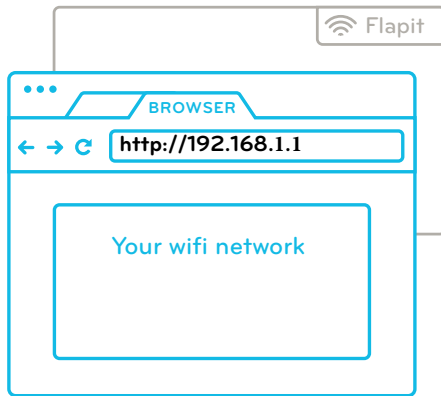


Launch your internet browser and open a new tab, if not automatically redirected. Then type the address: **http://192.168.1.1**

**Reconnect** your phone/computer to your usual wifi network.

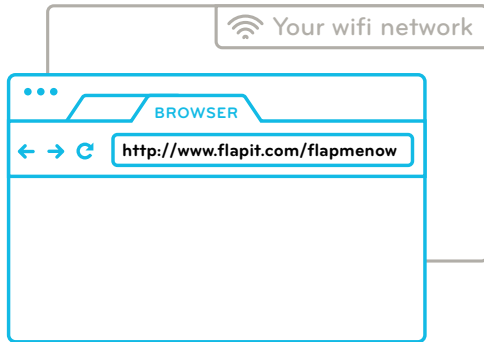
**PS:** once configured if you wish to connect another wifi network you must reset the device by pressing the reset button on the back of the device.

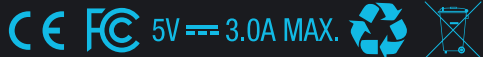
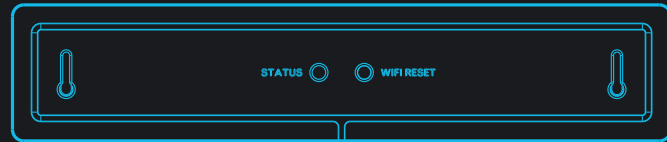
